Appointment information should be given only to the patient or to an individual known to be involved in the patient's care, such as the spouse or adult child of an incapacitated individual. An individual who serves in that capacity should be documented in the Problem List of the patient's medical record.~~

~~The Health and Human Services (HHS) department has stated that appointment reminders are allowed under the HIPAA Privacy Rule . When sending appointment reminders such as SMS, Email or Voice Calls you should not include detailed information about the person receiving the reminder.~~

~~The Federal Communication Commission has issued a Declaratory Ruling and Order to clarify the rules regarding HIPAA and patient telephone calls. The ruling also exempts covered entities and Business Entities from certain TCPA legislation in certain circumstances.~~
