Supporting Documentation Requirements for Home Health ...

In this article, home care refers to any health care given in the patient's home. Such care may be provided by Medicare-certified or Medicaid-certified home health agencies, visiting nurse associations, hospice nurses who make home visits, community health nurses who provide well-child care to at-risk mothers, and many other types of home care.

For example, Nancy is a 73-year-old woman receiving home health services after a right hip fracture treated with a total hip arthroplasty. She also has diabetes, which is managed poorly, resulting in proprioceptive deficits. She lives with her spouse, who is able to assist with care.

Did you know that in long term care (home health and SNF). . . the facility or agency pays up front for the care of each client. Then, the facility or agency is reimbursed for the specific care you provide after the care has already been provided and documented.

- Home health services are medically necessary services, which can be effectively and efficiently provided in the place of residence of a recipient. • Services include home health visits (nurse and home health aide), private duty nursing and personal care services for children, therapy services, medical supplies, and durable medical equipment.
